#### PARTICIPATION AGREEMENT AND RELEASE OF LIABILITY (minor)

I, , the parent or legal guardian of ,
desire for my child to participate in the Rice University School Mathematics Project's 2022 Summer Math Camps at St.
Mark's Episcopal School ("Activity") and,in consideration of him/her being allowed to participate in the Activity, I
acknowledge and agree as follows:

- 1. I understand that I am responsible for my child's own transportation to and from the Rice University camp location at St. Mark's Episcopal School. It is my responsibility to confirm the schedule in advance with the Activity's organizers.
- 2. I am fully informed or otherwise aware of, and fully assume, all risks to person and property in connection with my child's participation in the Activity, including but not limited to property damage and loss, bodily injuries, sickness, disease and death. My child is in sufficient health and able to participate (with or without an accommodation) in the Activity and I will contact the program organizers if there is a need to request an accommodation. I have medical insurance coverage appropriate for my child's participation in the Activity and have provided such insurance coverage information and emergency contact information to Rice University. Neither Rice University nor the Activity are providing any insurance for my child in connection with his/her participation in the Activity.
- 3. I understand that if my child requires medical treatment while participating in the Activity, an attempt will be made to notify me. In the event that I cannot be contacted, or if contact is impractical under the circumstances, I consent to medical treatment for my child as may be deemed necessary under the circumstances, including but not limited to x-ray examinations, surgery and anesthesia, and I will be responsible for any and all medical expenses.
- 4. If my child's participation in the Activity is at any time deemed detrimental to the Activity or its other participants, as determined by the Activity's organizers in their sole discretion, I understand that he/she may be expelled from the Activity without Rice University or the organizers incurring any liability.
- 5. I agree that my child will follow all of the Activity's policies and procedures regarding COVID-19 while participating in the Activity. I understand that COVID-19 is a highly contagious disease and my child may contract COVID-19 even if my child follows the safety precautions above. I also understand that, although Rice University will follow guidance from the CDC and state and local authorities to reduce the spread of COVID-19, Rice University cannot completely eliminate the risk of individuals participating in the Activity from contracting COVID-19. I agree to voluntarily assume all risks related to the COVID-19 virus.
- 6. I also grant Rice University the irrevocable right to use my child's image, voice and name in video, photographs and audio recordings of the Activity. I understand that this use may include publication and distribution in printed, electronic and digital media, including but not limited to Rice University brochures, video and television broadcasts, and website, social media and online communications. I also understand that my child will not receive any compensation in connection with this release.
- 7. I fully and forever RELEASE, WAIVE AND DISCHARGE, and COVENANT NOT TO SUE, Rice University (including, but not limited to, its trustees, employees and representatives) from and for any and all demands, claims, actions, suits, damages, losses, liabilities, costs and expenses (including but not limited to court costs and attorneys' fees), from any cause whatsoever (including but not limited to property damage and loss, bodily injuries, sickness, disease, the COVID-19 virus, and death), directly or indirectly arising in connection with my child's participation in the Activity, set up for the Activity, practice for the Activity, or transition to or from the Activity, or use of my child's image, voice or name by Rice University or its employees or independent contractors or the Activity pursuant to the foregoing rights grant, whether or not foreseeable or contributed to by the negligent acts or omissions of Rice University or others.
- 8. This Agreement constitutes the entire agreement about the subject matters it addresses and is governed by the laws of the State of Texas. If any provision of this Agreement is held unenforceable, this will not affect any other provision and this Agreement will be construed as if the unenforceable provision had not been incorporated in this Agreement. I (i) have read and fully understand this Agreement, (ii) intend that this Agreement be legally binding and enforceable upon me and my family, estate, heirs and legal representatives, and (iii) intend that this Agreement benefit Rice University. #### Assumption of Risk and Waiver of Liability Relating to COVID-19

In consideration of (print name of child) \_\_\_\_\_\_ being permitted to participate on campus at St. Mark's Episcopal School, its related events and activities, use of the equipment, facilities and services, I, as parent or guardian for the above child, agree as follows:

The novel coronavirus, known as Coronavirus Disease 2019 (COVID-19), which causes respiratory illness in people, has spread globally, including the United States. COVID-19 is **extremely contagious**. The World Health Organization has declared COVID-19 to be a worldwide pandemic.

After careful consideration, St. Mark's Episcopal School (the "School") has decided to conduct on-site Summer Camp beginning on June 6, 2022. Your enrolled child(ren) is/are welcome to join us on campus. However, please know that this is a family decision that should be made after careful assessment of the risks, current conditions in our community, and other factors you deem relevant and important. You acknowledge and understand that the circumstances regarding COVID-19 are changing from day to day and that accordingly, CDC, state, and local guidance is regularly modified and updated, and you accept full responsibility for familiarizing yourself with the most recent updates, as well as the changing conditions in our community, and all state and local orders. As such, you acknowledge and agree that you are aware of and have reviewed the Roadmap to Reopen Schools from Harris County that schools not operate on-site. You acknowledge that you have reviewed the School's protocols in place to prevent the spread of COVID-19, you have done your own review and research of local, state, and federal guidance, CDC guidance, and guidance from the American Academy of Pediatrics, and that you are aware of conflicting scientific opinions concerning the reopening of schools on campus. The decision whether to send and continue to send your child(ren) to our campus for Summer Camp is entirely voluntary on your part.

As the School conducts Summer Camp, the School has put in place preventative measures to reduce the spread of COVID-19. These precautions include measures such as screening, wearing masks, directing children and staff to regularly wash hands and practice healthy hygiene, practice social distancing, and regularly disinfecting areas of the School. Additional information on the precautions we have taken is available in the Summer Camp Handbook. The School cannot promise that even with the steps we are taking, that your child(ren) will not be exposed to COVID-

19. Therefore, if you choose to bring your child(ren) to Summer Camp, you acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that you and your child(ren) may be exposed to or infected by COVID-19 by coming to our campus, attending Summer Camp, and participating in School activities, such as but not limited to games with other children, the sharing of toys, supplies, belongings, and equipment, and that such exposure or infection may result in personal injury, illness, permanent disability, or death. You further acknowledge and understand the risk of becoming exposed to infected by COVID-19 may result from or be caused by the

actions, omissions, or negligence of yourself or others, including other Camp families, School employees, or other third parties.

You understand and acknowledge that you must not drop off any child that is experiencing any symptoms associated with COVID-19, including but not limited to fever, sore throat, shortness of breath, chills, muscle pain, new loss of taste or smell, gastrointestinal symptoms (like nausea, vomiting, or diarrhea), and cough. In addition, if your child is experiencing any symptoms once dropped off, you will be contacted to come and pick them up.

You agree to indemnify and hold the School and its past and present related entities and affiliates, predecessors, successors, assigns, representatives, agents, officers, trustees, students, employees, insurers, donors, agents, and attorneys (collectively, the "Indemnified Parties") harmless from any liability, loss, legal fees, judgments or damages the Indemnified Parties may suffer as a result of Claims asserted against them by your child(ren) or anyone on behalf of your child(ren) at any time in the future concerning, arising out of or related to the your child(ren)'s return to campus. In this regard, you agree to indemnify the Indemnified Parties to the fullest and broadest extent permitted by law from Claims asserted against them by your child(ren) or anyone on your child(ren)'s behalf at any time in the future concerning your child(ren)'s return to campus.

BY CHOOSING TO BRING YOUR CHILD(REN) TO CAMP, AND IN THEREOF. YOU, **JOINTLY** SEVERALLY. CONSIDERATION AND YOURSELF(VES), YOUR CHILD(REN) AND ALL OF YOUR AND YOUR CHILD(REN)'S RESPECTIVE GUARDIANS, HEIRS, EXECUTORS, PERSONAL AND LEGAL REPRESENTATIVES, ESTATES, BENEFICIARIES, ADMINISTRATORS, SUCCESSORS AND ASSIGNS (ALL OF THE FOREGOING, COLLECTIVELY THE "RELEASORS"), DO HEREBY WAIVE, RELEASE AND FOREVER DISCHARGE, AND PROMISE NOT TO SUE, THE SCHOOL, AND THEIR OFFICERS, DIRECTORS, TRUSTEES, SHAREHOLDERS, OWNERS, MANAGERS, PARTNERS, EMPLOYEES, STAFF, VOLUNTEERS, SUPERVISORS, AND ALL OF THEIR RESPECTIVE SUCCESSORS AND ASSIGNS, AS WELL AS ANY PERSON OR ENTITY ACTING BY, THROUGH, UNDER OR IN CONCERT WITH ANY OF THE FOREGOING PERSONS OR ENTITIES (THE SCHOOL AND ALL PERSONS AND ENTITIES RELEASED HEREIN ARE SOMETIMES COLLECTIVELY REFERRED TO AS THE "RELEASED PARTIES"), OF AND FROM ANY AND ALL LIABILITY AND/OR CLAIMS, CAUSES OF ACTION, SUITS, DAMAGES, DISPUTES, INJURY, ILLNESS, DISABILITY, DEATH, COSTS AND EXPENSES, AND DEMANDS OF ANY NATURE WHATSOEVER, KNOWN OR UNKNOWN, SUSPECTED OR UNSUSPECTED, AT LAW OR IN EQUITY, VESTED OR CONTINGENT, AGAINST ANY OR ALL OF THE RELEASED PARTIES WHICH YOU, YOUR CHILD(REN) AND ANY OF THE RELEASORS HAS, HAD, OR MAY HAVE AGAINST ANY OR ALL OF THE RELEASED PARTIES BY REASON OF PARTICIPATION IN THE SCHOOL ACTIVITIES OR BEING EXPOSED TO OR INFECTED BY COVID-19 AS A RESULT OF CHOOSING TO BRING YOUR CHILD(REN) TO THE SCHOOL (THE "CLAIMS"). THIS ASSUMPTION OF RISK AND WAIVER DOES NOT APPLY TO THE WILLFUL MISCONDUCT OF THE RELEASED PARTIES. THE RELEASORS HEREBY **KNOWINGLY** 

# VOLUNTARILY WAIVE, TO THE FULLEST EXTENT PERMITTED BY LAW, THE BENEFITS OF ANY STATUTE, LAW, RULE, OR COMMON LAW WHICH MAYLIMIT THE SCOPE OF THIS ASSUMPTION OF RISK AND WAIVER.

If any part of this Assumption of Risk and Waiver, or if the whole Assumption of Risk and Waiver is found to be invalid, unenforceable, or void, for any reason, then the Releasors acknowledge and agree that the Released Parties' entire liability to the Releasors or any other person shall never, under any circumstances, be more than any applicable insurance limits, even if one or more of the Released Parties was negligent or grossly negligent. In addition, the Releasors acknowledge that none of the Released Parties shall ever be liable to any person for special, incidental, consequential, or punitive damages or for any indirect damages such as, but not limited to, exemplary damages or lost earnings, lost revenues or loss of consortium, or companionship (even if the Released Parties have been advised of the possibility of such damages) whether based upon statute, contract, tort, negligence, strict liability, or otherwise.

By signing below you acknowledge that you have received the opportunity (and been strongly encouraged) to review this Assumption of Risk and Waiver with an attorney, that you have carefully read and fully understand the contents of this Assumption of Risk and Waiver, that you are giving up substantive legal rights (both your child(ren)'s and your own, as well as the rights of all other Releasors), have asked and received answers to all questions you may have, and that you have not been induced to sign this Assumption of Risk and Waiver by any promise or representation and sign it freely and voluntarily, intending and agreeing to be fully bound by the terms hereof. The parties agree and understand that a photocopy or an electronically signed waiver is an acceptable substitute for the original and holds the same force and effect as wet ink signature.

You also understand that it is your choice whether you sign this Assumption of Risk and Waiver, and instead of signing this Waiver, your enrolled child(ren) may engage in remote learning.
